We, the undersigned natural persons, who are of eighteen (18) years or more, acting as incorporates of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such a Corporation:

#### Article Onc

The name of the corporation is SCR PROPERTY OWNERS ASSOCIATION, INC.

#### Article Two

The corporation is a non-profit corporation.

#### Article Three

The period of duration is perpetual.

#### Article Four

The purposes for which the company is organized are:

- 1. To engage in the operation of a property owners association;
- To transact any and all lawful business for which any business may transact under the Act; and;
- To do everything necessary, proper, advisable or convenient for the accomplishment or furtherance of such purposes.

This corporation is organized pursuant to the Texas non-profit Corporation Act and does not contemplate pecuniary gain or profit to the members thereof and is organized for non-profit purposes.

#### Article Five

Should the Corporation dissolve, all net assets shall be transferred to an organization having tax exempt status under the rules and regulations of the IRS.


